While sharing a house with up to five other recovering individuals, residents are provided with fully furnished private or semi-private rooms containing "all the comforts of home."

The Cottages are located in an exclusive community that affords the residents the ability to seamlessly transition from a sequestered in-patient experience to a balanced functional sober lifestyle.

The GRR Multi-Phase Program provides the recovering substance abuser with a full time, structured and supervised sober environment. It is designed to help the individual implement healthy living patterns, take an interest in life after addiction and realize that recovery is a joy and a privilege.

The GRR Cottages are located ½ mile from the Indian River and 2 miles from the Atlantic Ocean. The Cottages possess all the charm of a property built in the 1920's and the comfort afforded by a recent complete renovation. This bright and cheerful home is equipped with central air.

The GRR Cottages offer residents the opportunity to enjoy spacious, comfortably furnished, common areas including self-service laundry and a fully outfitted kitchen.

During Phase I, residents are provided with transportation and a 24 hour buddy; at least one 12-Step meeting and 3 balanced meals daily; at least 4 spiritual growth groups, 4 visits to the gym and 4 activities weekly.

Residents may enjoy tennis, swimming, boating and peaceful moments under our jasmine and bougainvillea gazebo or near the water while enjoying immersion in the local recovery community.

A resident may move into Phase II once he or she is able to manage Phase I comfortably, is able to maintain his or her recovery commitments, has his or her counselor's approval, and has secured meaningful work, study or other constructive activity.
